- Strict **zero-tolerance policies on child labor and forced labor**
  - Promotion of **fair wages**, safe working conditions, and **gender equity** in all partner facilities
  - Collaboration only with **compliant factories** that meet BSCI, SEDEX, OEKO-TEX, or equivalent certifications

Sustainability is woven into the fabric of our operations. We are dedicated to minimizing our environmental footprint through:

- Partnering with manufacturers who utilize **eco-friendly dyes, organic cotton, and water-efficient processes**
  - Encouraging recycling and upcycling of overstock inventory through our **Textile Liquidator initiative**
  - Reducing carbon emissions by **regional diversification of sourcing** (Tajikistan for Europe/Russia, Pakistan for the US, etc.)
